 - (ii) the issue of specialised endorsements to seafarers to work on specialised ships such as chemical, gas and oil tankers, and passenger ships; and
 - (iii) the implementation of training and certification under the International Convention for Standards of Training, Certification and Watchkeeping for Fishing Vessel Personnel, 1995.
- 7. To prepare necessary Standards of Training, Certification and Watchkeeping guidelines and ensure their enforcement.
- 8. To conduct thorough assessment and audits of existing and potential Maritime Training Institutions.
- 9. To verify the implementation of Quality Standards System in approved Maritime Training Institutions.
