Role and Responsibilities:

To be responsible for all matters relating to inspections and investigations in line with the Data Protection Act and to assist the Data Protection Commissioner in the day-to-day administration of the Data Protection Office.

**Duties:** 

- 1. To be responsible to the Data Protection Commissioner for the performance of the following duties
  - (i) to supervise, monitor and coordinate the work, including research tasks, of officers in the Data Protection Officer's Cadre;

  - (iii) to supervise the inspections and advise on high risk processing operations and personal data breaches and assessments of security measures carried out by subordinate staff;
  - (iv) to supervise the periodical audits and certification mechanisms carried out by subordinate staff;
  - (v) to supervise the organisation of training for controllers and processors;
  - (vi) to take such measures, as may be necessary, to bring the provisions of the Data Protection Act to the knowledge of the general public;
  - (vii) to monitor registration, including online registration and renewal activities;
