Training Courses for Prosecutors and Enquiring Officers

This Ministry, in collaboration with the Office of the Director of Public Prosecution, is proposing to run a 5-day training course for Prosecutors and Enquiring Officers during the month of September 2015.

- 2. The objectives of the course are to enable participants to:
 - produce evidence in court and proceed with the enquiry stage, follow up and drafting of information including the charging of accused in an efficient way;
 - record statements from witnesses and assume the role of an enquiring officer in the cross examination of witnesses;
 - (iii) fulfill the role of a prosecutor efficiently; and
 - (iv) handle evidence and proof with utmost confidentiality.

The course contents are enclosed for your information.

- 3. It would be appreciated if you could designate and submit in order of priority, a list of officers posted in your Ministry/Department to follow the course, as per Pro-forma at Annex, by email on trainingmcsar@govmu.org and/or adkeesoondoyal@govmu.org. The list of your designated officers should reach the Ministry ad latest by Thursday 27 August 2015.
- 4. After the training, the officers are expected to share the knowledge acquired and skills developed with their colleagues, and their immediate supervisor will have to submit a report on the post training impact and transfer of learning.
