Anti-Corruption National Youth Forum (ANYF)

In line with the strategic objectives highlighted in this Ministry's Action Plan 2004-2005, a multi-faceted approach is being adopted to spearhead administrative reforms so as to enable the delivery of timely and quality services to the public and act as a catalyst for the development of human resources in the Civil Service. In this context, this Ministry is working in close collaboration with the Independent Commission Against Corruption (ICAC) to sensitize public officers in the adoption of anti-corruption practices.

2. With respect to its educational mandate, ICAC has designed a Youth Empowerment Programme (YEP), which aims at enlisting an effective youth participation in the national anti-corruption effort. Last year, ICAC organized the first ANYF which focused mainly on generating awareness among youth. Prior to the second forum which will be held shortly, ICAC is organizing a series of workshops to sensitize youth on corruption from different perspectives.

3. This Ministry has been entrusted with the responsibility to organize a workshop for public officers, aged 18-29, on the theme "Challenges to integrity in the Public Sector". The objective of the workshop is to promote a culture of integrity at workplace. The workshop will be held on **Tuesday 12 April 2005** from 09 00 to 13 00 hrs at the Lecture Theatre of this Ministry located on 6th floor, Fooks House, Bourbon street, Port Louis.

4. Participants of the workshops will be expected to reflect on the themes mentioned below and the outcomes will be presented and circulated at the second forum of the ANYF.

- perception of corruption and its impact on youth;
- how youth can contribute to curb corruption;
- measures to strengthen youth capabilities; and
- proposals to override perceived impediments to good governance and morality in their respective field of activity.

5. It would be appreciated if you would delegate **two (2)** representatives of your Ministry from the **age group 18-29**, from the Administrative, General Services or Technical Cadre to attend the workshop.

6. Kindly request the officers to fill in the enclosed Participation Form and forward same to the Administrative Reforms Unit of this Ministry by **Tuesday 05 April 2005**.
