Uniforms Allowances for Financial Year 2007/2008

The cash allowances to be paid to officers eligible for uniforms (excluding cardigan) for financial gar 2007/2008 have been approved as follows:-

| SN | Category | Amount (Rs) (excluding Cardigan) |

| (i) | Category I | |
| | A uniforms allowance paid to eligible officers whose nature of duties warrants a means of identification/authority | 2,790 |
| (ii) | Category II | |
| | A uniforms allowance paid to eligible officers whose nature of duties requires them to wear uniform as and when the need arises | 2,580 |
| (iii) | Category III | 37 |
| | A rapid wear and tear allowance paid to eligible officers whose nature of duties causes excessive wear and tear of clothing | 2,480 |

- It would be appreciated if you could take appropriate action accordingly and ensure that for Category I all eligible officers wear their uniforms while on duty and for Category II the eligible officers do whenever required. In that respect, an undertaking as per proforma at Annex should be signed by digible officers prior to the payment of the cash allowance to them.
- 1. As regards protective clothing/equipment, these should continue to be issued, wherever applicable. However, it should be ascertained that officers who are provided with protective clothing/equipment to make use of same in the performance of their duties. The attention of the officers should be trawn on the need to wear the protective clothing/equipment provided to them, and that cases of non ampliance may be liable to disciplinary action.
- Please note that any additional expenditure involved in the payment of the above allowances bould be contained within the allocated ceiling of your Ministry/Department for financial year 2007/2008.
