Public Service Excellence Award 2007

With a view to encourage innovation and excellence in the delivery of public services, the Public Service Excellence Award (PSEA) Scheme was introduced in the public service last year. The scheme aims at recognizing the achievements and contributions of Ministries/Departments and Units/Divisions that have excelled in service delivery through the use of innovative management tools and techniques.

- 2. The theme for the 2007 edition of the PSEA is 'In Pursuit of Excellence: Enhancing Trust in the Public Service'. This is in line with the United Nations 7th Global Forum on Re-inventing Government on the theme 'Building Trust in Government' held in Vienna in June 2007. As for the last edition of the scheme, the PSEA 2007 will be run in collaboration with the Mauritian Quality Institute (MQI) and University of Technology, Mauritius (UTM).
- Participating organizations will be evaluated by a Panel of Jury on the basis of the following four main judging criteria:
 - Leadership and Team Spirit;
 - (ii) Effectiveness and Efficiency:
 - (iii) Customer Focus; and
 - (iv) Innovation and Improvement.

The winner of the PSEA 2007 will be offered a cash prize of Rs 100,000/- and a shield. Based on the level of achievements, the Panel of Jury may decide to award individual cash prizes of Rs 50,000/- along with a souvenir shield in respect of each of the above judging criteria.

- Details of the PSEA 2007 are provided in the attached brochure which can also be downloaded from the website of the Ministry of Civil Service and Administrative Reforms at http://civilservice.gov. mu. All Ministries/Departments and their respective Units/Divisions are eligible to compete for the Award. Submissions should be made on the Participation Form which should be forwarded to the Administrative Reforms Division of the Ministry of Civil Service and Administrative Reforms by Thursday 31st January 2008 at latest.
