### Implementation of Pay Research Bureau Report 2008

Following the recommendations made in paragraph 15.14 of the Pay Research Bureau (PRB) Report 2008 about the creation of a new structure in the General Services falling under this Ministry, officers in the following grades in the existing structure have to be given the option to join the appropriate grades in the new structure as set out hereunder –

- 2. Forestalling the practical problems that would have arisen in the implementation of the recommendations made at paragraphs 15.14 (a) and (b) of the PRB Report and which would have disturbed the seniority placing of officers in the existing structure, the High Powered Committee has approved that all officers in the grades of Special Clerical Officer and Clerical Officer/Higher Clerical Officer be given the option to join the grade of Officer on the <u>same</u> date.
- The PRB recommended that Word Processing Operators and Senior Word Processing Operators possessing the qualifications prescribed for the new grade of Officer shall be given the option to join that grade as from 1 December 2008.

- 4. It has, therefore, been decided that the options to join the grades of Officer, Senior Officer and Office Management Executive would be effective as from 27 November 2008 (date on which the respective schemes of service have been prescribed).
- The option shall be irrevocable.
- 6. As recommended by the PRB, officers who opt to join the new grades of Officer, Senior Officer and Office Management Executive, as appropriate, would be granted one increment on joining the new grades.
- 7. Supervising Officers are kindly requested to bring the contents of this Circular Letter to the attention of officers concerned in the General Services posted to their Ministries/Departments, including those on approved leave with or without pay, and to make necessary arrangements for the officers to fill in the appropriate enclosed Option Forms. The duly filled in Forms should be forwarded to this Ministry by 26 April 2009 for officers in Mauritius and by 12 May 2009 for officers on approved leave abroad.
