The African Association for Public Administration and Management (AAPAM) is pleased to announce a call for Innovative Management Awards (IMA), 2024. The AAPAM Innovative Management Award is a continent-wide award programme, designed to recognize institutions, organizations and ministries which have adopted innovative and homegrown approaches to strengthen the delivery of public services in the Continent.

The purpose and objectives of the Award include the following:

- i. To recognize and publicize innovations in the public sector which are worthy of emulation.
- ii. To enhance the image of the public sector in Africa.
- iii. To promote innovation in the public sector by encouraging and recognizing organizations and people for creative and effective ways of solving specific problems of administration and management.
- iv. To facilitate the transfer of innovations and best practices as a way of improving the quality of Public Administration and Management in Africa.

Since its establishment in 2005, IMA has received widespread participation from African countries affirming that innovation in service delivery is essential for a productive, high-performing public service. AAPAM IMA is well aligned to Agenda 2063 and the SDGs in advocating for innovation as a key lever for the transformation and modernization of African public services for the attainment of sustainable development.

AAPAM welcomes submissions (in English, French and Arabic) from ministries, departments, agencies, sub-national levels and MDIs and Universities in Africa on any

institutional innovation promoting, best practices, excellence, and professionalism in service delivery in Africa and facilitating the achievement of national development plans, AU Agenda 2063 and SDGs.

The Awards will be given at the 43rd AAPAM Roundtable Conference to be held in Uganda, 25th to 29th November 2024. Winners and other leading entries will be extensively publicized with their executive summaries and featured in the AAPAM Website, publications, and other international networks.


