Fire Certificate - Framework Agreement for the Supply and Fixing of Fire Extinguishers, Emergency Lights and Fire Safety Signs

Since October 2021, a Framework Agreement has been devised at the level of this Ministry to facilitate the procurement of fire safety items, namely fire extinguishers, emergency lightings and fire safety signs by Ministries and Departments. This Agreement has, to a large extent, contributed in obtaining the required Fire Certificates in respect of office premises and other buildings.

- 2. Following a bid exercise, a new Framework Agreement is effective as from August 2024, which would be valid for a period of **12 months**.
- 3. Whenever your Ministry/Department is in need to procure the safety items, you will have to contact the following suppliers:-

- 5. Once the relevant items have been procured and installed in your respective Ministry/Department, the Mauritius Fire and Rescue Service (MFRS) should be informed to enable prompt inspection of the installation with a view to issuing a Fire Certificate in a timely manner.
