## **United Nations Public Service Day 2024**

At the Special Meeting of Senior Officers held today under the chair of the Secretary to Cabinet and Head of the Civil Service, you were informed that the United Nations Public Service Day 2024 will be celebrated on Sunday 23 June 2024 at the Swami Vivekananda International Convention Centre, Pailles as from 09 30 hours.

- 2. The theme for this year's celebration is "Fostering Innovation amid Global Challenges: a Public Sector Perspective".
- 3. In this context, this Ministry is organising a National Function and the Hon. Prime Minister will be the Chief Guest. Dr the Hon. Anjiv Ramdhany, Minister of Public Service, Administrative and Institutional Reforms and other eminent personalities will also be present.
- 4. The event aims to:
  - (i) showcase the talent of public officers, through different cultural and entertainment activities presented by them. These would include a drama, a folk dance, slams and musical medley (instrumental music);
  - (ii) display of the services offered by some key Ministries/Departments; and
  - (iii) launch a Souvenir Magazine and a Safety and Health Handbook for Supervising Officers/Accounting Officers.
- 5. I am making an appeal to you, in your capacity as Supervising Officer of your Ministry/Department, to mobilise all your staff to attend and participate in the event as this would be an opportunity to promote the role and professionalism of public officers while enhancing the visibility of the public service.
