## Panel of Experts on the Sudan

The Secretariat of the United Nations is inviting qualified individuals to serve on the Panel of Experts established pursuant to Resolution 1591 (2005) on the Sudan. The Panel of Experts on the Sudan, which comprises five experts, operates under the direction of the Security Council Committee established pursuant to the Resolution.

- 2. Candidates should possess a minimum of **ten years** of progressively responsible experience, with a minimum of three years of field experience, in the following relevant areas of expertise and competence in:
- (i) Arms;
- (ii) Armed groups;
- (iii) Finance;
- (iv) International humanitarian law; and
- (v) Regional issues.
