Monitoring of Interdicted Public Officers

The attention of this Ministry has been drawn to the significant costs incurred for the continued payment of salary to officers under interdiction.


2. To address this issue, this Ministry has set up a database to monitor the status of Interdicted Public Officers in Ministries/Departments on a monthly basis. However, it has been observed that some Ministries/Departments are not submitting the required information in a timely manner. Consequently, difficulties are being encountered to maintain an updated database of Interdicted Public Officers in the Civil Service.

3. In this connection, it would be appreciated if you could ensure submission on a monthly basis, of the following information pertaining to your Ministry/Department as per amended pro-forma at Annexes A to C

- (i) List of interdicted public officers - **Annex A (Tables 1, 2 & 3);**
- (ii) List of public officers who have been conditionally recalled from interdiction - **(Annex B);** and
- (iii) List of public officers who have been reinstated/dismissed/retired in the interest of the public service following the determination of their case - **(Annex C).**

4. The previous templates have been reviewed to enable the capture of additional information for the systematic monitoring of Interdicted Public Officers in the Civil Service.
5. The above information should be submitted by the 6th of every month on mcsarinterdiction@govmu.org.
6. A **NIL** return should also be submitted.
