Facilities at the Atal Bihari Vajpayee Institute of Public Service and Innovation

You will recall that new premises for housing the Civil Service College, Mauritius at Réduit (Minissy), Moka were inaugurated on 12 March 2025 by both Prime Ministers of India and Mauritius and has been named as the Atal Bihari Vajpayee Institute of Public Service and Innovation (AIPSI).

2. The Institute is now operational at the newly built compound, which is equipped with high-tech facilities as well as other modern training infrastructure at the Academic Block, including a Conference Hall and two Lecture Theatres as well as a canteen area with open terrace. Additional facilities now also comprise a fully equipped Auditorium with sophisticated sound systems.
