- Department:** Civil Aviation
- Post:** Air Traffic Control Officer
- Salary:** Rs 17,675 x 450 – 19,475 x 600 – 20,675 x 750 – 29,675 x 900 – 34,175 x 1,200 – 37,775 x 1,500 – 39,275 (03 39 66)
- Effective Date:** 28 May 2015
- Qualifications:** By appointment of Trainee Air Traffic Control Officers who have successfully completed their training.

NOTE 1

On appointment, following successful completion of the basic air traffic control course (ICAO Course 051) and either an aerodrome control course (ICAO Course 052) or an approach control course (ICAO Course 053) or an area control course (ICAO Course 055) (including rating and endorsement at the appropriate position), Air Traffic Control Officers will be required to successfully complete the two remaining courses as and when arranged by the Department and will be rated and endorsed at those positions.

NOTE 2

Air Traffic Control Officers will be required to undergo a medical examination to assess the standards of medical fitness including visual acuity, colour perception and hearing as recommended by the International Civil Aviation Organisation (ICAO).

- Duties:**
1. To be responsible for the provision of air traffic services and allied services in the Mauritius Flight Information Region (FIR) depending on the assigned operational position, such services may include any of the following -
 - Aerodrome Control Service
 - Approach Control Service
 - Area Control Service
 - Flight Information Service
 - Alerting Service

2. To provide emergency services to aircraft in need of assistance.
3. To notify pilots of any air navigation hazard and temporary restricted areas.
4. To provide such assistance to relevant Search and Rescue Authorities as may be required.
5. To co-ordinate with the aerodrome operator on the serviceability of runways, taxiways and movement areas in general.
6. To monitor the status of communication, navigation and surveillance facilities and to report any degradation therein.
7. To provide guidance and training to subordinate staff.
8. To use ICT in the performance of his duties.
9. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Air Traffic Control Officer in the roles ascribed to him.

Note

1. Air Traffic Control Officers will be required to work on shift, covering a 24-hour service including Saturdays, Sundays, Public Holidays and officially declared cyclone days and during emergencies.
2. Air Traffic Control Officers may be required to follow such theoretical, practical or on-the-job training courses locally and/or overseas in accordance with recommended ICAO standards.
3. Air Traffic Control Officers may be posted on a tour of service to Rodrigues or any of the Outer Islands of the Republic of Mauritius.
