- Ministry:** Education and Human Resources
- Post:** Trainee Teacher (Secondary) (Physical Education)
- Salary:** Rs 7,175 x 150 – 7,325 x 175 – 7,675 (06 18 21)
- Effective Date:** 14 November 2005
- Age Limit:** Between 18 and 35 years of age.
- Qualifications:**
  - A. (i) Cambridge School Certificate with credit in at least five subjects including English Language obtained at not more than two sittings or
  - (ii) Passes not below Grade C in at least five subjects including English Language obtained at not more than two sittings at the General Certificate of Education “Ordinary Level” provided that at one of the sittings, passes have been obtained either (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grade C in any one subject or
  - (iii) An equivalent qualification acceptable to the Public Service Commission.

**Note**

Candidates not possessing a credit in English Language at the Cambridge School Certificate will also be considered provided they possess passes in at least two subjects at “Principal Level” and one subject at “Subsidiary Level” as well as the General Paper obtained on one certificate at the Cambridge Higher School Certificate Examinations.

- B. A Cambridge Higher School Certificate or Passes in at least two subjects obtained on one certificate at the General Certificate of Education “Advanced Level” or an equivalent qualification acceptable to the Public Service Commission.

- C. Experience as
- (i) an athlete
  - or
  - (ii) an official in a sport competition
  - or
  - (iii) animateur or coach.

Qualification at A above should have been obtained prior to qualification at B above.

Candidates should produce written evidence from a recognised institution of any experience claimed.

**Training:**

1. To undergo a three-year training, both theoretical and practical, including the following of a part-time course leading to the Teacher's Diploma in Physical Education at a recognised institution or to an equivalent qualification acceptable to the Public Service Commission.
2. On successful completion of their training, including the obtention of the Teacher's Diploma in Physical Education or an equivalent qualification acceptable to the Public Service Commission, Trainee Teachers (Secondary) (Physical Education) will be eligible for appointment to the grade of Education Officer (Physical Education), as and when vacancies occur.
