- Qualifications:** By selection from among serving employees on the permanent and pensionable establishment who –
- (i) possess the National Trade Certificate (Level 3) in Masonry and Concrete Works issued jointly by the Mauritius Examinations Syndicate and the Industrial and Vocational Training Board (IVTB) [now Mauritius Institute of Training and Development (MITD)] or the National Certificate (Level 3) in Masonry or in Building Construction awarded by the Mauritius Institute of Training and Development (MITD) or an equivalent qualification acceptable to the Public Service Commission; and
  - (ii) have a knowledge of First Aid.

**NOTE**

In the absence of qualified serving employees, by selection from among candidates who –

- (i) possess the Certificate of Primary Education;
- (ii) possess the National Trade Certificate (Level 3) in Masonry and Concrete Works issued jointly by the Mauritius Examinations Syndicate and the Industrial and Vocational Training Board (IVTB) [now Mauritius Institute of Training and Development (MITD)] or the National Certificate (Level 3) in Masonry or in Building Construction awarded by the Mauritius Institute of Training and Development (MITD) or an equivalent qualification acceptable to the Public Service Commission; and
- (iii) have a knowledge of First Aid.

Candidates should produce written evidence of knowledge claimed.

**Duties:**

1. To carry out the necessary measurements and calculations of the trade in accordance with technical specifications.
2. To read scale plans, take off dimensions and set out foundations, levels, squareness of buildings accurately.
3. To dress stones or bricks for any purpose and to build various coursed stone walls in correct bond and build walls with all types of concrete blocks.
4. To point joints in stone walls, block walls and prepare walls for rendering.
5. To render in cement all surfaces and angles, and lay and trowel cement floors to levels.
6. To mix mortar and concrete and to place concrete for all concrete structures and buildings.
7. To lay floor tiles and wall tiles complete accurately finished to line and level.
8. To take off quantities of materials from plan and to prepare and lay reinforcements as defined in plans/drawings.
9. To advise on the use and purchase of materials, tools and equipment, as may be required.
10. To carry out works related to maintenance and repairs works before and after cyclones, flooding and other national disasters.
11. To make use of appropriate powered tools for the execution of works and to ensure good housekeeping of all tools generally used in the trade and the workplace.
12. To comply with safety and health standards.
13. To train and guide other workers under his supervision.
14. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Mason in the roles ascribed to him.
