Qualifications:

Candidates should possess the National Trade Certificate (Level 3) or National Certificate (Level 3) in Building Maintenance awarded by the Mauritius Institute of Training and Development or an equivalent qualification acceptable to the Public Service Commission.

Duties:

A. General Duties

- To read and work from sketches and drawings and to carry out the necessary measurements, estimates and calculations for each of the trade namely plumbing and pipe fitting, masonry, paint work, carpentry and cabinet making.
- 2. To carry out accurate setting out for all types of new structures.
- To erect tarpaulin tent and podium, to display flags, banderoles and other decorative items and laying of red carpets.
- 4. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Multi-Skilled Tradesman (Building Construction) in the roles ascribed to him.

B. For Masonry

- To mix and lay concrete according to mix required and after correct placing and fixing of reinforcement.
- 2. To build walls with concrete blocks, bricks and stones.
- To render in/plaster cement surfaces and angles and to lay and trowel cement floors to levels.
- 4. To lay floor and wall tiles accurately, finished to line and level.

C. For Carpentry and Cabinet-Making

- 1. To make by hand all types of glued, pinned, wedged, bolted or fitted joints required in interior work or heavy structure work.
- 2. To make and fix doors, windows louvers and fit hinges and mortise lock in doors.
- 3. To make all types of joints in cabinet making and simple mortise and tenon, mitre joints, plane and groove boards for panelling.
- To make and finish boarded panels, false ceiling and flooring and fix skirtings.
- 5. To carry out any type of repair work to existing timbered structures/furniture either by hand or by machines.
- 6. To cut glass panes and fix on windows and door openings.

D. For Plumbing and Pipe Fitting

- 1. To identify all types of fittings in plumbing works and to understand their uses.
- 2. To connect water system from CWA meter to buildings and execute necessary reductions and branches.
- To install baths, cistern siphons and overflow, urinals, wash hand basins and WC pans including appropriate traps and connect them to water supply.
- 4. To set out and carry out pipeline and construction of manholes for soil and waste water disposal.
- 5. To use soldering iron and execute soldered joints.
- 6. To use pipe wrench and tongs and make water tight joints and to use pipe cutter and hacksaw to cut pipe square or to any angle.
- 7. To prepare and replace common tap washers.

E. For Painting

- 1 To remove all paints with soda solution, wash and burn off paints and prepare surfaces for painting.
- 2. To sand paper, paint (brush), stop up, flat down with pumice and varnish (brush) and execute common methods of application of putty, paints and varnishes.
- To do ordinary lining, sign-writing and lettering.
- 4. To use spray painting equipment and keep same in good condition.
- 5. To mix and blend paints to any required shade.
