- Qualifications:**
- A. By selection from among serving employees on the permanent and pensionable establishment who –
- (i) possess the National Trade Certificate (Level 3) in Painting or in Peintre en Bâtiment et Décoration issued jointly by the Mauritius Examinations Syndicate and the Industrial and Vocational Training Board (IVTB) [now Mauritius Institute of Training and Development (MITD)] or the National Certificate (Level 3) in Painting awarded by the Mauritius Institute of Training and Development (MITD) or an equivalent qualification acceptable to the Public Service Commission; and
  - (ii) have a knowledge of First Aid.

**NOTE**

In the absence of qualified serving employees, by selection from among candidates who –

- (i) possess the Certificate of Primary Education;
- (ii) possess the National Trade Certificate (Level 3) in Painting or in Peintre en Bâtiment et Décoration issued jointly by the Mauritius Examinations Syndicate and the Industrial and Vocational Training Board (IVTB) [now Mauritius Institute of Training and Development (MITD)] or the National Certificate (Level 3) in Painting awarded by the Mauritius Institute of Training and Development (MITD) or an equivalent qualification acceptable to the Public Service Commission; and
- (iii) have a knowledge of First Aid.

B. Candidates selected under A and "NOTE" above should not be colour blind.

Candidates should produce written evidence of knowledge claimed.

**Duties:**

1. To carry out the necessary measurements and calculations of the trade in accordance with technical specifications.
2. To use all painter hand tools, including brushes, paint rollers, blowlamp and spray-painting equipment and maintain all tools in good condition.
3. To prepare surfaces for painting, remove old paint with paint remover, wash and burn off paint in accordance with technical specifications.
4. To make/prepare putty for use on metal or wood structures.
5. To sandpaper, paint, stop up, flat down with pumice and varnish and use common methods of application of putty, paints and varnishes.
6. To cut all weights of glass, mix putty and glaze.
7. To use spray painting equipment and keep same in good conditions.
8. To mix and blend paints to any required shade and use additives and driers.
9. To do ordinary distempering including preparation of walls, cutting of glass and simple glazing.
10. To make freehand sketches, read sketches and drawings which may be encountered in connection with the trade such as painting, colour schemes, lettering, glazing, lining and sign-writing.
11. To estimate all materials for puttying, painting, varnishing, glazing and any other operation pertaining to the trade.
12. To carry out works related to maintenance and repairs works before and after cyclones, flooding and other national disasters.

13. To use various kinds of paints, enamels, stains, varnishes and polishes.
14. To proficiently apply primers, undercoats, finishing coats in paint and enamel and leave the finishing coat in a satisfactory condition of finish.
15. To make use of appropriate powered tools for the execution of works and to ensure good housekeeping of all tools generally used in the trade and the workplace.
16. To comply with safety and health standards.
17. To train and guide other workers under his supervision.
18. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Painter in the roles ascribed to him.
