- Qualifications:** By selection from among serving employees on the permanent and pensionable establishment who –
- (i) possess the National Trade Certificate (Level 3) in Plumbing and Pipe Fitting issued jointly by the Mauritius Examinations Syndicate and the Industrial and Vocational Training Board (IVTB) [now Mauritius Institute of Training and Development (MITD)] or the National Certificate (Level 3) in Plumbing awarded by the Mauritius Institute of Training and Development (MITD) or an equivalent qualification acceptable to the Public Service Commission; and
 - (ii) have a knowledge of First Aid.

NOTE

In the absence of qualified serving employees, by selection from among candidates who –

- (i) possess the Certificate of Primary Education;
- (ii) possess the National Trade Certificate (Level 3) in Plumbing and Pipe Fitting issued jointly by the Mauritius Examinations Syndicate and the Industrial and Vocational Training Board (IVTB) [now Mauritius Institute of Training and Development (MITD)] or the National Certificate (Level 3) in Plumbing awarded by the Mauritius Institute of Training and Development (MITD) or an equivalent qualification acceptable to the Public Service Commission; and
- (iii) have a knowledge of First Aid.

Candidates should produce written evidence of knowledge claimed.

Duties:

1. To carry out the necessary measurements and calculations of the trade in accordance with technical specifications.
2. To name and use all tools of the trade, use pipe wrench and make watertight joints.
3. To identify all the fittings and fittings materials used in plumbing and make appropriate connections.
4. To lay pipes (galvanized, pvc and other types) for hot and cold water system.
5. To make a leak test on all connections and repair any leak.
6. To undertake all types of maintenance work related to hot and cold water system.
7. To identify and use proper glue material for respective pipe and fittings.
8. To prepare and replace common tap washers, lay soil pipes, lay cast iron piping and caulk joints to same in lead.
9. To use soldering iron and execute soldered joints and screw pipes with stocks and dies.
10. To use pipe cutter and hacksaw to cut pipe square or to a given angle and make lead traps for wash hand basins.
11. To connect water system from meter to buildings and execute necessary reductions and branches.
12. To install baths, cistern syphons and overflow, urinals and to connect them to water supply.
13. To read scale plans, take off dimensions and set out any domestic or industrial connections and sewer.
14. To prepare estimates for materials, labour and the time required to execute works for specific plumbing and pipe fitting works.

15. To carry out works related to maintenance and repairs works before and after cyclones, flooding and other national disasters.
16. To ensure that all works undertaken are of good quality and as per instructions.
17. To make use of appropriate powered tools for the execution of works and to ensure good housekeeping of all tools generally used in the trade and the workplace.
18. To comply with safety and health standards.
19. To train and guide other workers under his supervision.
20. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Plumber and Pipe Fitter in the roles ascribed to him.
