- Qualifications:** By promotion, on the basis of experience and merit, of officers in the grade of Specialised Nurse (Diabetes Foot Care) who reckon at least four years' service in a substantive capacity in the grade and who –
- (i) possess supervisory and managerial skills; and
 - (ii) are able to lead a team of officers.
- Role and Responsibilities:** To be responsible for the day-to-day management of the Diabetes Foot Care Clinics in the health region.
- Duties:**
1. To be responsible to the Consultant-in-Charge in the field of Endocrinology or an officer designated by him, or Charge Nurse (Male) or Charge Nurse (Female) for the performance of the following duties –
 - (i) to ensure the implementation of all policies relating to Diabetes Foot Care;
 - (ii) to supervise the work of Specialised Nurses (Diabetes Foot Care);
 - (iii) to maintain and supervise the smooth running of diabetes of non-healing foot ulcer specialist nursing service at hospital and primary health care levels;
 - (iv) to manage Diabetes Foot Care Clinics in hospitals/Area Health Centres/Community Health Centres;
 - (v) to coordinate the care of diabetes foot patients;
 - (vi) to organise community participative sessions for prevention of diabetes complications in relation to foot care;
 - (vii) to organise and facilitate training for Specialised Nurses (Diabetes Foot Care);

- (viii) to participate in studies and surveys related to Diabetes Foot Care;
 - (ix) to attend and participate in multi-disciplinary clinical and research meetings;
 - (x) to submit regular programme of work to the Consultant-in-Charge in the field of Endocrinology or Charge Nurse (Male) or Charge Nurse (Female); and
 - (xi) to work in collaboration with multi-disciplinary teams in the development of protocols and clinical nursing policies with regard to Diabetes Foot Care.
2. To use ICT in the performance of his duties.
 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Senior Specialised Nurse (Diabetes Foot Care) in the roles ascribed to him.

Note

Senior Specialised Nurses (Diabetes Foot Care) will be required to work at staggered hours.
