## NOTE 3

In the absence of qualified candidates under "NOTE 2" who possess the qualifications at (i) above, consideration will be given to those who show proof of being literate.

## **Duties:**

- 1. To carry out
  - (i) necessary measurements and calculations on vehicles, plant and equipment in accordance with technical specifications;
  - (ii) repairs and adjustments to carburettors, fuel injection systems, clutches, gear boxes, couplings, front and rear axles, differentials, brakes, steering systems and suspensions; and
  - (iii) servicing on vehicles and plant.
- 2. To troubleshoot faults on vehicles, plant and equipment and effect the necessary repairs.
- 3. To dismantle, overhaul and re-assemble engines of motor vehicles, generators, plant and equipment.
- 4. To use and maintain in good condition all tools, equipment and accessories pertaining to the trade.
- 5. To ensure that all operations regarding the use of specific tools and equipment are carried out within safe workshop practices.
- 6. To train and guide Tradesman's Assistants engaged in the same trade and other workers under his supervision.
- 7. To interpret services data from workshop manual.
- 8. To advise on the use and purchase of spare parts, materials, tools and equipment, as may be required.
- 9. To drive motor vehicles for testing purposes.
- 10. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Motor Mechanic in the roles ascribed to him.
