Role and Responsibilities:

To assist in fostering the advancement and transfer of knowledge so as to meet the increasing need for skilled and trained manpower in the maritime sector.

Duties:

- 1. To be responsible for training in all aspects of engineering machinery and systems used on board ships.
- 2. To design and develop marine engineering training courses in accordance with requirements of any Convention to which Mauritius is a party, such as the Standard of Training, Certification and Watchkeeping for Seafarers (STCW 1995) as amended.
- 3. To supervise the work of Marine Engineering Instructors.
- 4. To plan, administer, co-ordinate and supervise marine engineering courses.
- 5. To give advice on matters relating to the training of marine engineering personnel working on board fishing, merchant and other vessels.
- 6. To give lectures on subjects pertaining to marine engineering and maritime safety.
- 7. To liaise with other maritime administrations to design new courses and update other courses in line with Conventions in force.
- 8. To develop practical courses in Marine Engineering and liaise with other training institutions in the implementation of such courses.
- 9. To use ICT in the performance of his duties.
- 10. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Head, Engineering Department in the roles ascribed to him.
