Qualifications:

By selection from among employees on the permanent and pensionable establishment of the Police Service Department who –

- (i) possess the Certificate of Primary Education or the Primary School Achievement Certificate; and
- (ii) are competent to carry out all sorts of carpentry work such as preparing target veneers, cutting them to shape and fitting hit switch clamps.

NOTE 1

In the absence of suitably qualified employees of the Department possessing the qualification at (i) above, consideration will be given to those who show proof of being literate and who possess the qualification at (ii) above.

NOTE 2

In the absence of suitably qualified employees of the Department, by selection from among candidates who possess the qualifications at (i) and (ii) above.

Candidates should produce written evidence of knowledge claimed.

NOTE 3

Selected candidates will be appointed in a temporary capacity in the first instance and will be required to undergo an appropriate training, as approved and arranged by the Police Service Department and carried out at the Special Mobile Force, for an initial period of six months, in all aspects of the work of a Range Warden, which includes the following –

- (i) the use of basic hand tools;
- (ii) mechanically propelled equipment and electrical equipment;

- (iii) first aid; and
- (iv) Occupational Safety and Health at work.

On satisfactory completion of the training and on being favourably reported upon, they will be considered for appointment to the grade of Range Warden in a substantive capacity, as and when vacancies occur.

Duties:

- 1. To work under the supervision of the police officers designated as weapon training officer and firing point officer and be responsible for
 - (a) the upkeep and maintenance of all Special Mobile Force Ranges;
 - (b) displaying red flags and red lamps as required by Range Orders;
 - (c) preparing target veneers, cutting them to shape and fitting hit switch clamps;
 - (d) ensuring -
 - (i) the safekeeping, stocking and issue of range stores such as warning flags, signs, sandbags and so forth;
 - (ii) the security of the range under lock and key at the end of a day's practice and also when not in use; and
 - (iii) general cleanliness of the ranges and range buildings.
 - (e) making up and repairing target screens;
 - (f) sifting and raking of sand in butts and maintaining bullet catches in accordance with weapon training officer's instructions;
 - (g) fitting triple bar target arms;
 - (h) carrying minor repairs to the range structure, such as target pits and runs, mantlets and firing point shelters;

- (i) greasing and non-technical servicing of fitted metal parts range equipment;
- (j) preparing the range to meet the requirements of the users and briefing them on the specific instructions regarding the use of the range;
- (k) recording defects and damage arising from use of firing practices; and
- (l) using all tools and equipment within safe working practices and ensuring that they are kept safe, clean and maintained in good working conditions.
- 2. To comply with instructions given to him by the firing point officer in such matters as hours of practice, stores, targets and apparatus and inform him of any hazard.
- 3. To report any hazard or whenever Range Orders are not being followed to the weapon training officer at the earliest.
- 4. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Range Warden in the roles ascribed to him.
