**SCHEME OF SERVICE SPECIFIED UNDER REGULATION 15 OF THE
PUBLIC SERVICE COMMISSION REGULATIONS**

- Department:** Police Service
- Post:** Swimming Pool Attendant
- Salary:** Rs 15,485 x 260 – 17,825 x 275 – 18,925 x 300 – 19,525 x 325 – 21,475 x 375 – 22,225 x 400 – 23,425 x 525 – 26,050 x 675 – 27,400 (24 025 058)
- Effective Date:** 02 August 2023
- Qualifications:** By selection from among employees on the permanent and pensionable establishment of the Police Service Department who –
- (i) possess the Certificate of Primary Education or the Primary School Achievement Certificate (PSAC);
 - (ii) have passed an aptitude test to be carried out at the Special Mobile Force/Police Training School (SMF/PTS) swimming pool under the supervision of an officer designated as chief physical training instructor to assess their swimming skills for at least 25 metres at a stretch; and
 - (iii) have a knowledge of First Aid.

NOTE 1

In the absence of suitably qualified employees of the Department possessing the qualifications at (i) above, consideration will be given to those who show proof of being literate.

NOTE 2

In the absence of suitably qualified employees of the Department, by selection from among candidates who possess the qualifications at (i), (ii) and (iii) above.

NOTE 3

Selected candidates will be appointed in a temporary capacity in the first instance and will be required to follow an appropriate training for an initial period of two months, to be arranged and carried out at the Special Mobile Force/Police Training School (SMF/PTS). On satisfactory completion of the training and on being favourably reported upon, they will be considered for appointment as Swimming Pool Attendant in a substantive capacity, as and when vacancies occur.

Candidates should produce written evidence of knowledge claimed.

Duties:

1. To work under the supervision of the police officers designated as chief physical training instructor and be responsible for –
 - (i) the opening and closing of the swimming pool complex, offices, cloakrooms, bathrooms and toilets;
 - (ii) the upkeep and maintenance of the swimming pool and deck, showers, toilets and accessories;
 - (iii) adding chlorine and other chemicals to the swimming pool, as and when instructed by the officer in charge of the swimming pool;
 - (iv) collecting pool water specimen weekly for analysis;
 - (v) cleaning the pool accessories and backwashing the pool filter regularly;
 - (vi) the daily vacuum cleaning of the pool flooring and walls;
 - (vii) monitoring and ensuring proper safekeeping and stocking of pool chemicals and other accessories;
 - (viii) preparing the pool for swimming practices;
 - (ix) displaying red flags when the pool is not accessible;
 - (x) the security of the pool during swimming practices;
 - (xi) using all tools and equipment within safe working practices and ensuring that they are kept safe, clean and maintained in good working conditions; and
 - (xii) reporting any hazard to the officer in charge of the swimming pool at the earliest.
