  - providing regular personal monitoring services to radiation workers and reporting on findings;

- (ii) maintaining the dosimetry records of radiation workers;
- (iii) providing nuclear analytical services;
- (iv) repairing and maintaining nuclear instrumentation of the Radiation Protection Authority as well as that of licensees;
- (v) assisting licensees in establishing a quality assurance and radiation protection programme for their facilities; and
- (vi) participating in the Radiation Protection Authority's training activities.
- 2. To assist the Radiation Protection Officer (Services) in the performance of his duties.
- 3. To use ICT in the performance of his duties.
- 4. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from Radiation Protection Assistants in the roles ascribed to them.
