- (vi) ensuring the maintenance of the national register of sources, facilities and licensees; and
- (vii) preparing and making periodic assessment of the effectiveness of authorisation guides and inspection manual.
- 2. To supervise and coordinate the work of subordinate staff.
- 3. To implement and participate in training programmes for technical staff of licensees and of the Radiation Protection Authority.
- 4. To represent the Radiation Protection Authority in meetings and committees, as and when required.
- 5. To use ICT in the performance of his duties.
- 6. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Senior Radiation Protection Officer in the roles ascribed to him.

### Note

The Senior Radiation Protection Officer may be required to work outside normal working hours including Sundays, Public Holidays and officially declared cyclone days.
