- (b) have a knowledge of First Aid.

NOTE

In the absence of qualified serving employees, by selection from among candidates who –

- (i) possess the Certificate of Primary Education;
- (ii) possess the National Trade Certificate (Level 3) in Automotive Electricity and Electronics issued jointly by the Mauritius Examinations Syndicate and the Industrial and Vocational Training Board (IVTB) [now Mauritius Institute of Training and Development (MITD)] or the National Certificate (Level 3) in Automotive Electricity and Electronics awarded by the Mauritius Institute of Training and Development (MITD) or an equivalent qualification acceptable to the Public Service Commission; and
- (iii) have a knowledge of First Aid.

Duties:

- 1. To carry out necessary measurements and calculations of the trade in accordance with technical specifications.
- 2. To test, service, adjust and repair ignition, starting, charging, lighting and electronics systems.
- 3. To fill, charge and maintain a battery in good order (test specific gravity of electrolyte, the level thereof, cleanliness of terminal, seating of battery and others) and clean surfaces attacked by acid.
- 4. To solder wires together and wires to plug, and install wiring using simple wiring system.
- 5. To diagnose and repair any fault in the lighting system of an automobile, test lamps, remove and replace a fuse if necessary.
- 6. To remove, dismantle, clean and reassemble generators and starter motors, and replace worn brushes in the generator or the starter motor.
- 7. To trace and remedy any electrical fault that may develop in an automobile (faulty condenser, coil and others).
- 8. To make out time sheets and keep simple records in English or French.
- 9. To make use of appropriate powered tools for the execution of works and to ensure good housekeeping of all tools generally used in the trade and the workplace.
- 10. To comply with safety and health standards.
- 11. To train and guide other workers under his supervision.
- 12. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Automobile Electrician in the roles ascribed to him.
