Qualifications: By selection from among serving employees on the permanent and pensionable establishment who –

- (a) possess the National Trade Certificate (Level 3) in Welding and Metal Fabrication issued jointly by the Mauritius Examinations Syndicate and the Industrial and Vocational Training Board (IVTB) [now Mauritius Institute of Training and Development (MITD)] or the National Certificate (Level 3) in Welding awarded by the Mauritius Institute of Training and Development (MITD) or an equivalent qualification acceptable to the Public Service Commission; and
- (b) have a knowledge of First Aid.

NOTE

In the absence of qualified serving employees, by selection from among candidates who –

- (i) possess the Certificate of Primary Education;
- (ii) possess the National Trade Certificate (Level 3) in Welding and Metal Fabrication issued jointly by the Mauritius Examinations Syndicate and the Industrial and Vocational Training Board (IVTB) [now Mauritius Institute of Training and Development (MITD)] or the National Certificate (Level 3) in Welding awarded by the Mauritius Institute of Training and Development (MITD) or an equivalent qualification acceptable to the Public Service Commission; and
- (iii) have a knowledge of First Aid.

Candidates should produce written evidence of knowledge claimed.

Duties:

1. To select the most suitable electrodes, to cut and prepare metals for welding.
2. To carry out –
 - (i) necessary measurements and calculations of the trade in accordance with technical specifications;
 - (ii) all forms of welding works in all thickness of materials in an efficient manner;
 - (iii) accurate outside and inside welds between plates and between angle irons; and
 - (iv) welding works on the basis of simple drawings or sketches.
3. To make sound welds in down-hand, oblique, vertical and up-hand positions.
4. To use appropriate welding techniques to control expansion and contraction of metals, and to adopt correct measures to avoid under-cutting.
5. To use correctly the tools, equipment and accessories pertaining to the trade.
6. To prepare estimates with regard to type and quantities of materials required for specific works.
7. To obtain materials from Procurement and Supply Section using correct procedures.
8. To make use of appropriate powered tools, inclusive of oxy-acetylene gas and arc welding equipment, for the execution of works and to ensure good housekeeping of all tools generally used in the trade and the workplace.
9. To comply with safety and health standards.
10. To train and guide other workers under his supervision.
11. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Welder in the roles ascribed to him.
