  - (ii) possess a Goods Vehicle Driving Licence (manual gear) and a Licence to drive tractors; and
  - (iii) reckon at least five years' experience in driving, out of which a minimum of at least three years' experience in the driving of Goods Vehicles and tractors.

Candidates should submit documentary evidence for experience/knowledge claimed.

## **Duties:**

- 1. To be responsible to officer in charge of the Station where posted for the performance of the following duties
  - (i) to operate tractor implements such as harrow, plough, rotary hoe, tynes, planter, seed drill, leveling blades and other earth-moving equipment e.g. mowers, brushcutter, harvester, sprayers, manure spreader, slurry tanker, fertilizer applicator, loader and any other agricultural machinery designed to be attached to tractors;
  - (ii) to operate any machinery powered by the power take-off of wheel and tractors;
  - (iii) to operate self-powered agricultural and earth-moving machineries and equipment fitted with wheel or track;
  - (iv) to carry out all necessary adjustments on tractor and implements for proper execution of work; and
  - (v) to service and maintain in good condition tractor and implements/agricultural machineries as required by the schedules of maintenance.
- 2. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Agricultural Implement Operator in the roles ascribed to him.
