

- Organisation:** Rodrigues Regional Assembly (Forestry)
- Post:** Head, Forestry
- Salary:** Rs 31,725 x 775 – 32,500 x 925 – 37,125 x 1,225 – 40,800 x 1,525 – 49,950 x 1,625 – 54,825 (19 062 080)
- Effective Date:** 31 May 2017
- Qualifications:** By promotion, on the basis of experience and merit, of officers in the grade of Chief Forest Conservation and Enforcement Officer who reckon at least two years' service in a substantive capacity in the grade and who –
- (i) have a sound knowledge of forest-related laws and regulations;
  - (ii) possess good communication, interpersonal and leadership skills; and
  - (iii) are able to motivate a team of officers.
- Role and Responsibilities:** To be responsible for the proper administration and management of the Forestry Services and the restoration of natural terrestrial fauna and flora.
- Duties:**
1. To be responsible for –
    - (a) the planning, co-ordination and supervision of all aspects of works of the Forestry Services;
    - (b) the proper use and management of all assets of the Forestry Services;
    - (c) the conservation of the forest ecosystem in Rodrigues; and
    - (d) audit inspections in the Forestry Services with a view to guard against irregularity and fraud.
  2. To ensure that the relevant laws relating to the forest sector are properly enforced.
  3. To assist in the preparation of draft regulations relating to the forest sector, as and when required.
