Workshop on "Inclusive Green Economy in Mauritius"

The United Nations Institute for Training and Research (UNITAR) in collaboration with this Ministry and the Civil Service College, Mauritius, is organising a one-day Workshop on the theme "Inclusive Green Economy in Mauritius: What skills do we need?". The Workshop will be held on Monday 3 April 2017 at Le Sirius Conference Room, Le Labourdonais Waterfront Hotel, Caudan, Port Louis. The agenda for the Workshop is at Annex 1.

The overall goal of the Workshop is to increase awareness of Public Officers and Stakeholders of the knowledge and capacities needed to develop and implement measures that advance inclusive green economy in Mauritius. It will highlight the linkage between the concept of Inclusive Green Economy (IGE), the development priorities of Mauritius, and the capacities needed to enable sustainable economic development. It will also facilitate a dialogue on capacities for inclusive green economy and explain the objectives of the Partnership for Action on Green Economy (PAGE), an organisation which brings together five UN agencies which have combined their respective expertise and networks in order to offer an integrated and holistic support to countries seeking to advance inclusive green economy. PAGE provides support to the Government of Mauritius through advisory and capacity building services and is supporting national institutions in providing effective capacity building for inclusive green economy to Public Officers in Mauritius.

In order to make this Workshop a success, I am soliciting your collaboration through the nomination of <u>two</u> senior officers not below the level of Deputy Permanent Secretary, including senior officials of the Technical cadres of the level of Director, to attend.
