2019 United Nations Public Service Awards (UNPSA)

The United Nations Department of Economic and Social Affairs, through its Division for Public Institutions and Digital Government, is inviting nominations for the 2019 United Nations Public Service Awards (UNPSA).

- 2. The purpose of the UNPSA is to promote and reward innovation and excellence in public service for sustainable development in support of the realization of the Sustainable Development Goals (SDGs) and the principle to leave no one behind, which is at the core of the 2030 Agenda. It also takes into account the various levels of development of countries while reflecting the universal nature of the SDGs. This global competition seeks to promote the role, professionalism and visibility of the public service by highlighting innovations in governance and rewarding excellence in the public sector and also raising the image of public service.
- 3. The 2019 UNPSA will be given to those public sector institutions that have distinguished themselves in one of the following categories:
 - (i) Category 1 Delivering inclusive and equitable services to leave no one behind
 - (ii) Category 2 Ensuring integrated approaches in the public-sector institutions
 - (iii) Category 3 Developing effective and accountable public institutions
 - (iv) Category 4 Promoting digital transformation in public sector institutions
 - (v) Category 5 Promoting gender responsive public services to achieve the SDGS
- 4. The Award is open to all public-sector institutions at the national, state and local levels from all UN member states. All public sector organisations having implemented innovative projects and programmes relevant to one of the above-mentioned categories for a minimum of two years, with demonstrated and documented impact are eligible to participate.

The UNPSA evaluation process consists of several rounds of evaluation to be conducted by the UNPSA Evaluation Team, as well as a sub-committee of the United Nations Committee of Experts on Public Administration. Awards will be conferred to winners on 23 June 2019, during the UNPSA Ceremony which is part of the United Nations Public Service Forum.
