Intra-Urban Travelling

At present, officers who attend duty by bus are being refunded travelling expenses incurred r journeys between their residence and place of work by the most economical route, provided distance is not less than 1.6 kms. Refund of travelling expenses is also being effected to ficers travelling to and from Victoria Square/Immigration Square although the distance is less in 1.6 kms.

Representations have been received to the effect that some officers who have recourse to tra-urban transport to enable them to reach office on time should be refunded the travelling sits incurred.

With a view to evaluating the financial implications of the representations made and the stent of the problem, it would be appreciated if the annexed proforma could be filled and inwarded to this Ministry not later than <u>Thursday 30 September 2010</u>.
