Regular Quota Status of Mauritius as at 15 August 2023

The African Union Commission (AUC) has, through the Ministry of Foreign Affairs, Regional Integration and International Trade, submitted the African Union regular Quota Status of Mauritius as at 15 August 2023 as well as the list of Mauritian nationals working at the AUC.
