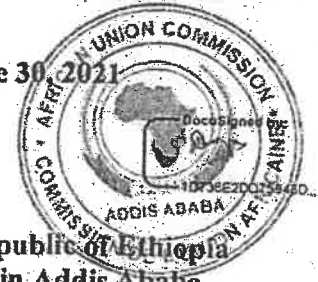
In its paragraph 27, the above Executive Council Decision provides as follows:
