Public Service Excellence Award 2017

The Ministry of Civil Service and Administrative Reforms is pleased to invite participation in the Public Service Excellence Award (PSEA). The theme retained for this year's edition is "Fostering creativity and innovation to better respond to citizens' needs". This theme is meant to give an added dimension to the ongoing effort of Government to improve the quality of service dispensed to the public in general, in line with Vision 2030 and the 3-Year Strategic Plan.

- 2. Participation in the PSEA is opened to all Ministries/Departments as well as their respective Divisions /Units. However, Grand Winners of the previous editions of the Award are not eligible for participation for the next two editions following the year of their award.
- 3. The PSEA, as you are aware, has over the years, emerged as one of the most appropriate tools to steer the Civil Service as a dynamic, customer-centric and performing institution to reach new heights. This has also helped to both encourage public officers to work in team and to promote a culture of excellence in the Civil Service. The overall objective is, therefore, to recognise and reward meritorious efforts on the part of the Ministries/Departments and their respective Divisions/Units which have gone the extra mile to meaningfully improve public service delivery.
- 4. As from this year, the participation guidelines have been reviewed to take on board the main aspects of the Public Sector Business Transformation (PSBT) Strategy. The information elicited by the Entry Form would, henceforth, focus on the best practices adopted by Ministries/Departments and which have contributed to make substantial changes/improvements in management practices and public service delivery level. The participating Ministries/Departments will be required to bring forth their achievements for the past 12 months and to highlight the reasons that would qualify them to be the potential winner of the Award.

5. The selected best three entries will receive in order of merit the Gold, Silver or Bronze Awards. The Winners will also be offered cash prizes as follows –

Gold Award:

Rs 100,000

Silver Award:

Rs 60,000

Bronze Award:

Rs 40,000

Hence, a strong appeal is, hereby made to all Supervising Officers to ensure participation, accordingly.
