 - (ii) passes not below Grade C in Chemistry, Physics and Mathematics or Principles of Accounts obtained at not more than two sittings at the General Certificate of Education "Ordinary Level" provided that at one of the sittings, passes have been obtained either (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grade C in any one subject.
 - (b) the National Trade Certificate Level 2 in the field of Communication Electronics issued jointly by the Mauritius Examinations Syndicate and the Mauritius Institute of Training and Development (formerly the Industrial Vocational and Training Board).

OR

Equivalent qualifications to A above acceptable to the Public Service Commission.

Duties:
