

Qualifications:

By appointment of a Trainee Engineer of the Department who is registered as a Professional Engineer of Mauritius, under Section 13 of Act No 49 of 1965 as subsequently amended, and who has completed his pre-registration training in the Department in either Airframe and Power-Plant or Avionics and Electrics.

Duties:

1. To examine and make reports and recommendations to the Director, through the Principal Engineer concerned, on the following applications:
 - (a) for registration/deregistration and change of ownership of aircraft;
 - (b) for issue/validation and renewal of certificate of airworthiness of aircraft in cases where policy directives are called for;
 - (c) for issue/extension/renewal of aircraft maintenance engineers and welders licences/certificates;
 - (d) for issue/variation/validation of air operator's certificate.
2. To scrutinize technical literature issued by the manufacturer of aircraft and its equipment and other airworthiness authorities for its applicability to aircraft registered in Mauritius and initiate action for compliance and issue of directives where necessary.
3. To investigate major defects discovered in the aircraft registered in Mauritius and in consultation with the Principal Engineer concerned determine corrective action to be taken to avoid such recurrences.
4. To perform such action as may be assigned in the review and approval of maintenance schedules/manuals submitted by the aircraft operators and the issuance, renewal and validation of certificates of airworthiness.
5. To conduct surveillance of the facilities of the organisations approved by the Department of Civil Aviation.
6. To inspect and report on aircraft operators' route stations as may be required.

7. To monitor maintenance training programmes of certificated operators.
8. To perform such duties as may be assigned in investigating aircraft accidents.
9. To assist in the periodic review of aviation regulations and airworthiness requirements based on operational experience.
10. To be responsible for the training of junior airworthiness personnel in accordance with departmental policies.
11. To assist in administrative duties of the Airworthiness Section.
12. To perform such cognate duties as may be assigned.

NOTE:

The Airworthiness Engineer may be required to work outside the normal hours of work, including Sundays and Public Holidays and during cyclonic periods.
