Qualifications:


1. By selection from among officers in the grades of (a) Senior Education Officer (Administration); and  
(b) Education Officer reckoning at least five years service in a substantive capacity in the grade.

2. Candidates should possess:-

- (A) (i) a Cambridge School Certificate with credit in at least five subjects including English Language obtained on one certificate or a General Certificate of Education 'Ordinary Level' with passes not below grade C in at least five subjects including English Language obtained on one certificate;
- (ii) a Cambridge Higher School Certificate with passes at Principal Level in at least two subjects or a General Certificate of Education 'Advanced Level' with passes in at least two subjects obtained on one certificate;
- (iii) a degree or joint Degree from a recognised University;

(iv) a Postgraduate Certificate or a Diploma in Education or having successfully completed one year full-time (or equivalent part-time) postgraduate course in Education or Educational Administration or in approved subjects in the educational field.

OR

- (v) Equivalent qualifications to (i), (ii), (iii) and (iv) above acceptable to the Public Service Commission.
- (B) (i) knowledge of modern trends and development in the field of education;
- (ii) knowledge of Government educational policies, rules and regulations; and
- (iii) ability to guide and advise on policies and programmes to be implemented.

NOTE 1

Selected candidates will be appointed in the first instance in a temporary capacity. They will be required to successfully complete a training course of at least nine months duration (both theoretical and practical) to be considered for appointment as Secondary School Inspector in a substantive capacity.

For the first intake, priority of consideration will be given to:-


- (a) Senior Education Officers (Administration) reckoning experience in supervision of pedagogical and related duties in secondary schools; and
- (b) Persons serving as Inspector in the Private Secondary Schools Authority provided they possess a degree or joint degree from a recognised institution.

Duties:

- 1. To carry out system evaluation and submit assessment reports.
- 2. To assist on Curriculum panels when required to do so and evaluate curricular materials produced.
- 3. To ensure maximum utilization of resources in schools.
- 4. To advise schools in connection with all innovative programmes/policies to be implemented and to be advised by Heads of Schools on the degree of success.
- 5. To assist in Staff Development Programmes.
- 6. To evolve with parent agencies testing and assessment tools.
- 7. To help promote growth and development of the system and ensure smooth transition across levels.
