- (f) receiving, processing and submitting annual statistics for all the X-Ray Units;
- (g) submitting new proposals for plants, equipment, furniture, materials and supplies for all X-Ray Units;
- (h) co-ordinating and submitting lists of annual requirements of X-Ray films, drugs, chemicals and other supplies for the X-Ray Units, within the budgetary limits to Procurement and Supply section;
