- 3. To form part of the clinical team and advise in the designing of insoles, orthopaedic shoes and foot prostheses.
- 4. To examine patients who are in need of special insoles, orthopaedic shoes and foot prostheses and also sophisticated orthopaedic appliances and to keep a record thereof.
- 5. To evaluate the insoles, orthopaedic shoes and foot prostheses for use and advise accordingly.
- 6. To take casts and measurements and to devise orthopaedic appliances including the conception of models, choice of materials, components and other parts.
- 7. To modify the negative and the positive models or drawings of orthopaedic appliances so as to obtain the best adjustment and alignment.
- 8. To perform the static and dynamic alignment of orthopaedic appliances on patients.
- 9. To manufacture orthoses and prostheses and other orthopaedic appliances including components, parts, suspension systems and to perform the finishing work on orthopaedic appliances.
- 10. To participate in
  - (i) fitting the orthopaedic appliance on patient and his training in the proper use of the appliance;
  - (ii) the evaluation of the product and provide advice as required; and
  - (iii) the planning and setting up of the technical orthopaedic services system.
- 11. To advise the patient and/or his family on the use and maintenance of the appliance.
- 12. To follow up the usage of insoles, orthopaedic shoes and foot prostheses and adjust accordingly.
