Duties:

- 3. To establish special programmes of education with emphasis on the responsibility of the parents for their health and that of their children and family.
- 4. To visit regularly the centres and to submit reports, as and when required.
- 5. To supervise the work of Senior Midwife (on shift) and Senior Midwife and to prepare their duty roster.
- 6. To participate in the practical training of Trainee Midwives and Nursing Officers following post basic course in Midwifery and help in the conduct of Midwifery exams.
