Qualifications: By selection, on the basis of experience and merit, of Field Workers (Female) (Family Planning) and Clinical Assistants, Family Planning, Maternal and Child Health Services who reckon at least 5 years' experience in Family Planning and who have passed a written examination conducted by the Public Service Commission.

Note:

Priority of consideration will be given to the following officers who will be exempted from the written examination:-

(a) Field Workers (Female) (Family Planning) who reckon at least twelve months' service of a comparable nature with that of Supervisor (Female) (Family Planning) with the Mauritius Family Planning Association before its integration with the Ministry of Health on the 22nd November, 1972, and

(b) Clerks (Female) (Family Planning) who have satisfactorily performed the duties of Supervisor (Female) (Family Planning) for at least one year.

Duties:

1. To be responsible to the Senior Supervisor for:-
  - (a) Supervising, in the area assigned to her, the day-to-day work of Field Workers and Clinical Assistants;
  - (b) performing home visits, carrying out surveys and submitting returns;
  - (c) motivating and educating the target population on family planning.

2. To perform other cognate duties.
