Qualifications:

By promotion, on the basis of experience and merit, of officers in the grade of Divisional Occupational Safety and Health Officer who reckon at least three years' service in a substantive capacity in the grade and who have the ability to lead and motivate a team of officers.

Role and Responsibilities:

To assist in the promotion of an Occupational Safety and Health Culture in line with the provisions of the Occupational Safety and Health Act.

**Duties:** 

- 1. To assist the Director, Occupational Safety and Health in the discharge of his duties and in particular to be responsible to him for
  - (a) the efficient running of the Occupational Safety and Health Inspectorate;
  - (b) the supervision and training of officers of the Occupational Safety and Health Inspectorate;
  - (c) the enforcement of legislation on safety, health and welfare at work;
  - (d) reviewing and updating appropriate legislation, as may be required;
  - (e) investigating into accidents and dangerous occurrences at work places;
  - (f) ensuring that measures are taken for the promotion of proper health, safety and welfare environment at work;
  - (g) advising employers, workers' representatives and workers on safety, health and welfare at work;
