- 3. To assess project requirements and researching feasibility.
- 4. To plan and supervise the construction of vessels.
- 5. To negotiate and agree on project budgets, timescales and specifications with clients in case of a Government project.
- 6. To produce detailed designs of ships, boats and other maritime vessels using drawings and specialist computer software.
- 7. To develop and utilise test procedures including computer modeling and scale models.
- 8. To interpret and analyse data and test results.
- 9. To advise on the specifications of equipment for ships.
- 10. To conduct a risk analysis of ships and marine structures and to assess aspects of designs such as strengths, stability and lifesaving equipment.
- 11. To ensure adherence to appropriate maritime health and safety legislation/standards.
- 12. To identify the need for, and supervise vessel repairs.
- 13. To assist marine accident investigators in analysing data and writing accident reports.
- 14. To undertake relevant research on ships in general.
- 15. To provide technical advice on ship's building matters especially to ship owners willing to register vessels under the Mauritius Flag.
- 16. To calculate or verify grounding, towing, salvage wreck removal or any other calculations pertaining to vessels, submitted to the Ministry for the purpose of operations at sea.
