- Qualifications:** By promotion, on the basis of experience and merit, of officers in the grades of Senior Scientific Officer (Environment) and Scientific Officer (Environment) in post as at 31 December 2015 who reckon an aggregate of at least six years' service in a substantive capacity in the Cadre and who –
- (i) have a wide knowledge in the field of environmental laboratory analysis;
 - (ii) possess strong leadership, communication and organising skills; and
 - (iii) have a high sense of responsibility.
- Role and Responsibilities:** To assist in the formulation and execution of policies related to the development of new techniques as regards the monitoring of the environment.
- Duties:**
1. To be responsible to the Deputy Director of Environment for –
 - (i) the general administration and management of the National Environmental Laboratory;
 - (ii) matters of human resources and capacity building including appropriate training needs of the staff;
 - (iii) the appraisal, preparation and timely execution and supervision of case studies assigned to the National Environmental Laboratory and reporting thereon;
 - (iv) the continuous upgrading of the services provided by the National Environmental Laboratory in line with international standards; and
 - (v) the implementation of quality assurance/quality control procedures and documentation in accordance with MS ISO standards within the National Environmental Laboratory.
