4. The application and supporting documents should also be sent, **in hard copy (1 original + 2 Copies)**, to this Ministry, Attn: **Miss Y. Namooya**, together with the following documents by **15 June 2017**:

- (i) Survey and undertaking forms; and
- (ii) Medical and X-ray reports.

5. All necessary clearances, as appropriate, should be sought by the nominating Ministry/ Department for all applications submitted to this Ministry and all procedures should be followed as set out in this Ministry Circular No. 41 of 2016.

6. Applicants should imperatively obtain confirmation from their respective Supervising Officers that they would be released in the event they are selected for the scholarship. Upon selection, officers concerned would be eligible for study leave as governed by Section 10 of Chapter 4 of the Human Resource Management Manual (HRMM) and would be required to enter into a bond in accordance with the provisions laid down in the said manual.

7. The final decision to award the scholarship to the nominees rests solely with the donor country.

8. It would be appreciated if the contents of this circular letter could be brought to the attention of all eligible public officers serving in your Ministry/Department, including those in Statutory Bodies falling under the purview of your Ministry/ Department.
