## Vacancies at the World Trade Organization (WTO)

The Secretariat of the World Trade Organization (WTO) is inviting nominations for the following posts:

- (a) Director of Rules Division;
- (b) Director of the Institute for Training and Technical Cooperation; and
- (c) Director of the Development Division.

### 2. <u>Director of Rules Division</u>

- (a) The Director will lead the Rules Division which is responsible, among others, for all matters-in the areas of subsidies, contingent trade remedies state trading enterprises and trade in civil aircraft including negotiations dispute settlement, implementation, surveillance and technical assistance.
- (b) Applicants should hold an advanced university degree, preferably in Economics or Law, and a minimum of fifteen years of relevant experience including substantial work experience in an international environment excellent knowledge of the WTO system and of legal and economic issues in the areas within the Division's competence.

## B. The Director of the Institute for Training and Technical Cooperation

(a) The Director will lead the Institute for Training and Technical Cooperation which is responsible for all matters relating to technical assistance. (b) Applicants should hold an advanced university degree, or proven professional expertise equivalent to an advanced academic degree, in Economics, International Trade Law or related fields with a technical assistance component as well as fifteen years of relevant experience, including substantial work experience in an international environment and an excellent knowledge of the WTO system.

#### The Director of the Development Division

- (a) The Director will lead the Development Division which is responsible for all matters relating to development.
- (b) Applicants should hold an advanced university degree, or proven professional expertise, equivalent to an advanced academic degree, in Economics, International Trade Law or related fields with a development component as well as fifteen years of relevant experience, including substantial work experience in an international environment and an excellent knowledge of the WTO system.
- 3. Each of the above three posts has a starting salary of approximately 187,800 Swiss Francs per annum and is for a fixed-term of two years, with possibility of extension.
