Review of Monetary Ceilings for the purchase of Official Cars

The High Powered Committee, at its meeting of 27 June 2013, has decided that the monetary ceilings for the purchase of official cars be revised as follows:

Categories of Officers	Existing Ceiling Values (Rs)	New Ceiling Values (Rs)
Officers drawing a monthly salary of Rs 95000 in position of Accounting/Responsible Officer	850,000	900,000
Officers drawing salary of Rs 102,000 and up to Rs 111,000	1,070,000	1,130,000
Officers drawing salary of more than Rs 111,000 and up to Rs 114,000	1,070,000	1,220,000
Officers drawing a monthly salary of above Rs 114,000 and up to Rs 144,000 as well as the Deputy Master and Registrar and Judge in Bankruptcy	1,420,000	1,500,000
Officers drawing a monthly salary of more than Rs 144,000	1,700,000	1,800,000

2. Supervising Officers are apprised of the above decision for necessary action with respect to the purchase of official cars.

3. It would be appreciated if the contents of this Circular Letter could be brought to the attention of eligible officers of your Ministry/Department as well as those in the Parastatal and other Statutory Bodies falling under the aegis of your respective Ministry.



(i) Officers drawing a monthly salary of Rs 95,000 in position of Accounting/Responsible Officer	20,000	24,000
(ii) Officers drawing a monthly salary of Rs 102,000 and up to Rs 114,000	25,000	30,000
(iii) Officers drawing a monthly salary of more than Rs 114,000 and up to Rs 144,000 as well as the Deputy Master and Registrar and Judge in Bankruptcy	25,000	30,000
(iv) Officers drawing a monthly salary of more than Rs 144,000	30,000	36,000
