Revision of Fuel Allowances and Car Allowances for Beneficiaries of Official Car

The High Powered Committee has decided, at its meeting of 02 May 2013, that the quantum of the monthly fuel allowances which was last reviewed on 01 July 2008, be revised with effect from 01 March 2013 as set out hereunder:-


